PROPOSED PROPERTY DESCRIPTIONS

PARCEL A:

That part of the Northwest Quarter of the Southeast Quarter of Section 25, Township 121, Range 26, Wright County, Minnesota, except therefrom:

That part of said Northwest Quarter of the Southeast Quarter of Section 25, Township 121, Range 26, Wright County, Minnesota, described as follows:

Beginning at the Northeast corner of said Northwest Quarter of the Southeast Quarter; thence on an assumed bearing of South 03 degrees 34 minutes 18 seconds West, along the East line of said Northwest Quarter of the Southeast Quarter, a distance of 1511.45 feet to the Southeast corner of said Northwest Quarter of the Southeast Quarter; thence South 88 degrees 13 minutes 38 seconds West, along the South line of said Northwest Quarter of the Southeast Quarter, a distance of 102.97 feet; thence North 07 degrees 26 minutes 36 seconds East, a distance of 508.20 feet; thence North 05 degrees 15 minutes 06 seconds East, a distance of 386.94 feet; thence North 08 degrees 45 minutes 04 seconds East, a distance of 426.39 feet to the point of beginning.

That lies Northerly of Line A and Easterly of Line B.

Beginning at the Northeast corner of said Northeast Quarter of the Southwest Quarter of said Section 25; thence running South 546.00 feet; thence Northwesterly 438.00 feet to a point which is 411.00 feet South of the North line of said Northeast Quarter of the Southwest Quarter; thence North 411.00 feet to a point on the North line of the Northeast Quarter of the Southwest Quarter which is 373.00 feet West of the point of beginning; thence East to the point of beginning.

North 88 degrees 37 minutes 34 seconds East, a distance of 1617.59 feet to the East line of said Southwest Quarter of the Southeast Quarter and said Line C there terminating.

PARCEL F:

That part of the Southwest Quarter of the Southeast Quarter of Section 25, Township 121, Range 26, Wright County, Minnesota, that lies South of Line C and North of Line D.

Line C is described as follows:

Commencing at the Southwest corner of said Southwest Quarter of the Southeast Quarter; thence on an assumed bearing of North 06 degrees 53 minutes 36 seconds East, along the West line of said Southwest Quarter of the Southeast Quarter, a distance of 873.80 feet to the point of beginning of said Line C; thence North 88 degrees 37 minutes 34 seconds East, a distance of 1617.59 feet to the East line of said Southwest Quarter of the Southeast Quarter and said Line C there terminating.

Line D is described as follows:

Commencing at the Southwest corner of said Southwest Quarter of the Southeast Quarter; thence on an assumed bearing of North 06 degrees 53 minutes 36 seconds East, along the West line of said Southwest Quarter of the Southeast Quarter, a distance of 405.50 feet to the point of beginning of said Line D; thence North 81 degrees 02 minutes 18 seconds East, a distance of 1678.71 feet to the East line of said Southwest Quarter of the Southeast Quarter and said Line D there terminating.

PARCEL G:

That part of Government Lot 2, Section 25, Township 121, Range 26, Wright County, Minnesota, lying Southwesterly of the West Arm of Black Lake.

AND

That part of the Southwest Quarter of the Southeast Quarter of Section 25, Township 121, Range 26, Wright County, Minnesota, that lies Southerly of Line D.

Line D is described as follows:

Commencing at the Southwest corner of said Southwest Quarter of the Southeast Quarter; thence on an assumed bearing of North 06 degrees 53 minutes 36 seconds East, along the West line of said Southwest Quarter of the Southeast Quarter, a distance of 405.50 feet to the point of beginning of said Line D; thence North 81 degrees 02 minutes 18 seconds East, a distance of 1678.71 feet to the

East line of said Southwest Quarter of the Southeast Quarter and said Line D there terminating.
